


CAIR-CALIFORNIA is a civil rights advocacy organization dedicated to promoting justice, enhancing the understanding of Islam and Muslims, and empowering the American-Muslim Community.

Oversaw 1,150 civil rights cases on behalf of Muslims who were discriminated against because of their religious practices. Conducted 304 educational workshops and presentations and held 773 community outreach events. Contributed to 599 print articles and broadcast media pieces to educate the public about Islam and discrimination against Muslims. Provided representation and support to 406 immigrants' rights cases.

Made a financial contribution to a tax-exempt charitable/educational organization for program support (\$1,525).

4b (Code: n/a) (Expenses \$ 221,597 including grants of \$ -0-) (Revenue \$ -0-)

Conducted the 11th Annual Muslim Youth Leadership Program, in which 42 high school students went to the state capitol in Sacramento for a 4-day training. The program featured workshops on community organizing and advocacy, public speaking, and an opportunity to conduct a mock legislative session in the state Senate.

Conducted the "Explore the Qur'an" project, where 229 copies of the Holy Qur'an were distributed to politicians, interfaith leaders and other public officials across California. The purpose was to promote mutual understanding of Islam.

Participated with Japanese-American organizations in a civic engagement program where Muslim and Japanese high school students learn about activism, civil rights challenges, and leadership. Took 37 Muslim students on the annual trip to Manzanar, a WW2 Japanese-American internment camp. The purpose was to promote better understanding of past civil rights violations and promote activism and advocacy in support of the civil rights of all people in America.

Conducted five (5) banquets throughout California, attended by more than 4,200 members of the community, including public officials, law enforcement personnel, interfaith leaders, etc. The purpose was to present to the public the programs, services and activity accomplishments of our organization, to highlight different civil rights cases, and to raise funds.
