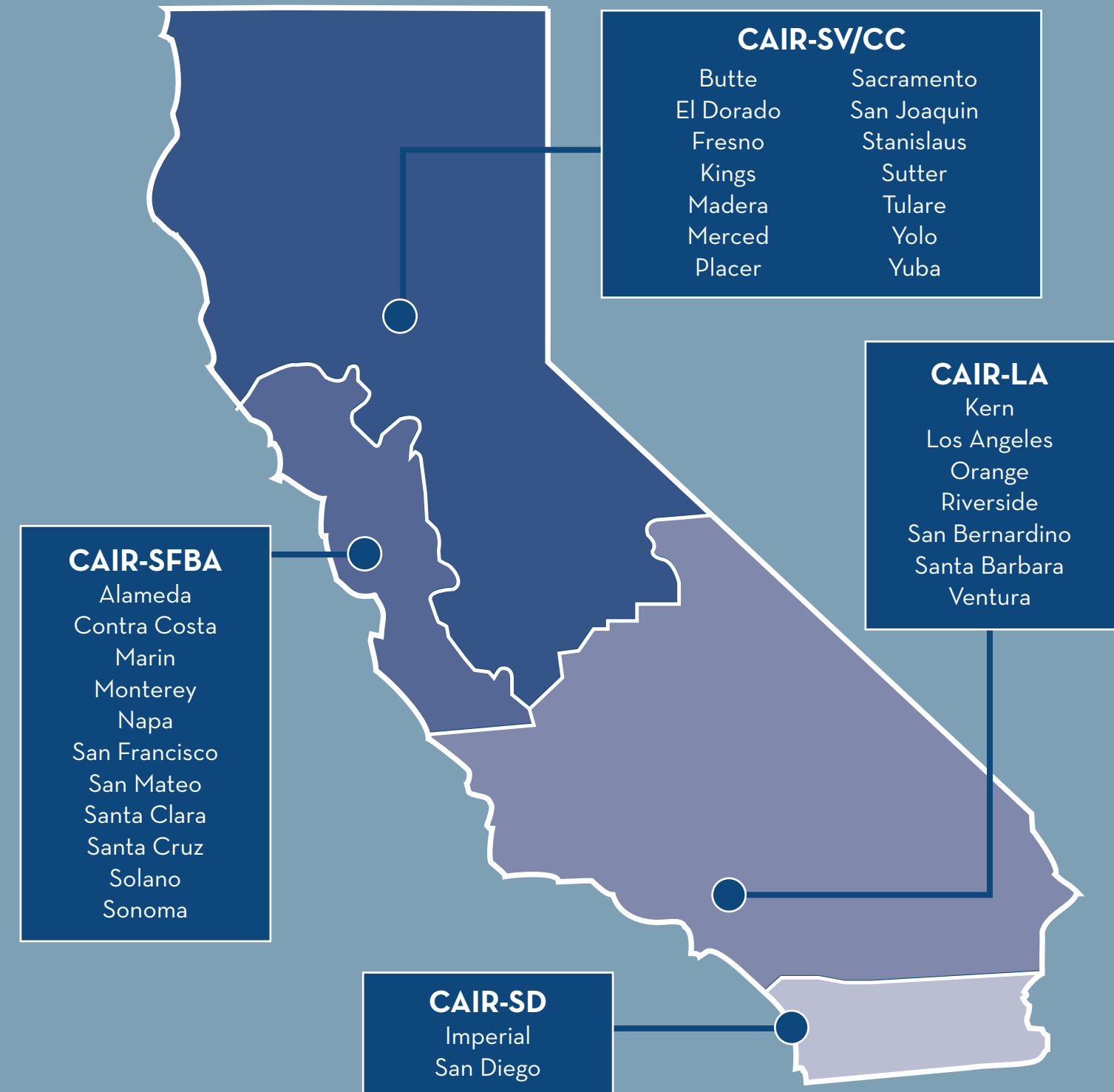

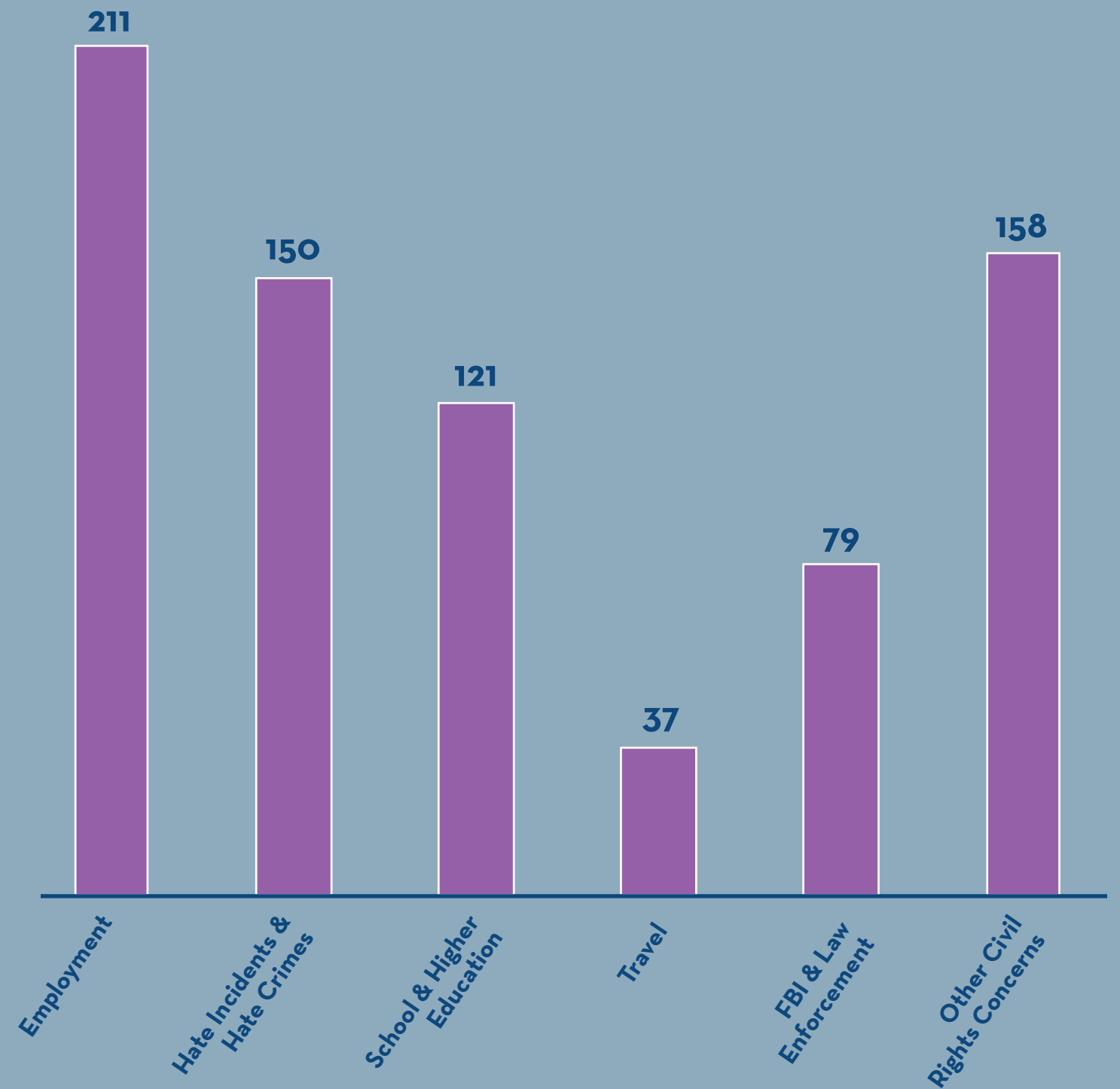

POLICY CHANGE AFTER MUSLIM WOMAN REQUIRED TO REMOVE HIJAB IN JAIL

After a young Muslim woman was required to remove her hijab during a custody stay at the Santa Clara County Main Jail—the second such incident in two years—CAIR-CA and the Santa Clara County Sheriff’s Office reached a settlement to ensure such violations of religious freedom do not recur. The settlement included financial compensation of \$90,000 and, crucially, the establishment of a new policy that mandates that individuals in custody, including during the booking process, are allowed to retain their head coverings or are provided with suitable alternatives. For situations where removal is necessary for safety reasons, such as pat-downs or mental health evaluations, the policy stipulates that it must occur in a private setting or away from men.



NEW COLLEGE DISTRICT RESOLUTION AFTER PROFESSOR’S ISLAMOPHOBIC COMMENTS

CAIR-CA and the Rancho Santiago Community College District Board of Trustees passed a joint resolution, ‘Recognizing Muslim Religious Observances and the Muslim Community,’ in a public meeting on Monday, July 17, 2023.

The joint resolution was introduced in response to an Islamophobic incident at Santa Ana College (SAC) two years prior when SAC Adjunct Professor Jamie McDonough was recorded making Islamophobic statements during an Introduction to Psychology lecture. Her statements degraded Muslim women and characterized Muslim men as barbaric and misogynistic, perpetuating harmful anti-Muslim stereotypes and biases.

CHARGES DROPPED AGAINST NEWLY ARRIVED AFGHAN TEENAGER SHOT BY THE POLICE

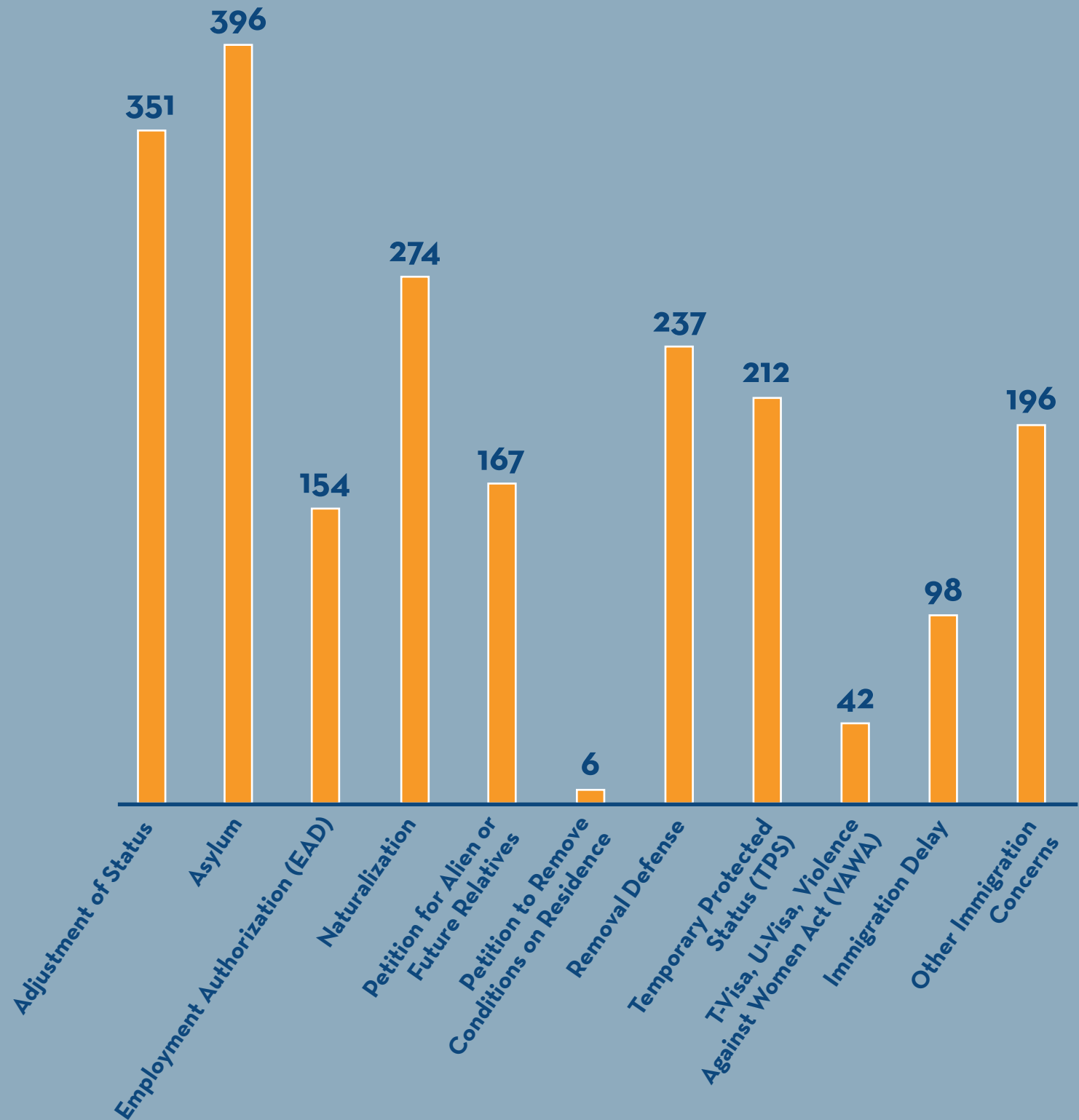
In January 2023, a newly arrived teenage boy from Afghanistan was shot by a police officer in Central California. The police had been called by a neighbor, who saw the boy pursuing his brother while holding a knife. Both boys were in traditional Afghan clothing. When the police officer arrived, he instructed the boy to drop the knife. He did not understand him, so he did not comply. The boy was shot twice and badly injured, requiring two surgeries. While recovering from surgery, CAIR-CA learned that the boy was being criminally charged and retained expert counsel for him. The boy is doing well, and his case was dismissed with the charges against him completely dropped.

AFGHAN ROBOTICS TEAM AND FAMILY GRANTED ASYLUM

In 2017, the Afghan Robotics Team made headlines when the United States twice denied its members visas needed to compete in the country. Then-President Donald Trump stepped in, and they were able to participate.

After the fall of the Afghan government in 2021, three of the original members of the team, Fatemah, Lida, and Kawsar, fled to Ireland with the help of a nonprofit organization to escape the chaos, fighting, and danger to their lives in their country. Their parents and family remained behind in Afghanistan. They were terrified for their families' safety due to the risks associated with supporting the girls' activities in the Robotics Team and their ambitions in STEM education and careers.

Fortunately, their families were evacuated by the U.S. military and given humanitarian parole to enter the U.S., where most of them settled in Southern California.

Humanitarian Parole status is a temporary status that does not lead to permanent residency, so the nonprofit organization that helped evacuate the girls to Ireland contacted CAIR-CA for assistance with their parents' and siblings' asylum applications. CAIR-CA's immigration team helped their families in Southern California apply for asylum by completing and submitting their applications, preparing them for the interview process, and representing them during their asylum interviews. They also directly represented Kawsar and Fatemah's mothers and mentored and provided guidance to the attorneys at O'Melveny & Myers law firm, who were the pro bono attorneys for Lida's mom and brother. In addition, CAIR-CA represented their adult sisters and brothers in their asylum applications. Although it was a long and complex process to navigate the asylum process, all family members have been granted asylum.

CLASS ACTION LAWSUIT VICTORY FOR AFGHAN REFUGEES

CAIR-CA celebrated a significant victory with the successful settlement of a class action lawsuit involving Afghan asylees against the U.S. Citizenship and Immigration Services (USCIS). This landmark case, *Ahmed et al v. Department of Homeland Security et al*, began in the wake of the U.S. withdrawal from Afghanistan in 2021 and the subsequent rise of the Taliban. The U.S.-initiated Operation Allies Welcome promised to process asylum applications within 150 days. However, two years later, thousands of asylees, including CAIR-CA client and lawsuit plaintiff Mursal Sadat, were left in limbo, still awaiting decisions on their applications. For two years, as Mursal awaited asylum approval, she was unable to visit her ill parents and siblings who had escaped to Pakistan.

The successful settlement, reached between the U.S. government and attorneys from Kirkland & Ellis and the National Immigrant Justice Center, mandates timely processing of these applications.

CITIZENSHIP FOR AN 85-YEAR-OLD WIDOW

CAIR-CA successfully assisted an 85-year-old Kenyan national of Pakistani descent in obtaining U.S. citizenship. A widow since the 1990s, she suffered a stroke 20 years ago, leaving her left side paralyzed and reliant on a wheelchair. At her first naturalization interview, USCIS made this wheelchair-bound client wait nearly three hours past her scheduled interview time and did not allow for accurate interpretation. Instead, the USCIS officer rejected her medical waiver for the English and civics portions of the naturalization interview, ignoring her diagnosed and visible cognitive and physical disabilities. Despite being flustered and scared, she passed the English portion of the exam on the spot, sufficiently reading, writing, and speaking in English. During her second naturalization interview, a new USCIS officer immediately accepted the medical waiver and granted her U.S. citizenship.

AN ELDERLY TUNISIAN MAN STAYS IN AMERICA

CAIR-CA defended an elderly Tunisian community member in a deportation defense case. He had been waiting for a case resolution for many years and was later placed in removal proceedings as the USCIS did not approve his removal condition. Thanks to the work of the team, his case was dismissed, and he was able to stay in his new home in San Diego.

ASYLUM WIN AGAINST THE DEPARTMENT OF HOMELAND SECURITY FOR A YEMENI FAMILY

A lifelong member of the Yemeni military was nominated by his army in 2013 to study counter-terrorism at a prestigious U.S. military graduate school. During his studies, the situation in Yemen deteriorated drastically when the Houthis overthrew the government, placing him in direct conflict with the new regime due to his military background, family's political ties, and academic work in the U.S. Consequently, for his and his family's safety, he filed for asylum in 2014.

His journey to asylum was challenging, and he faced immigration court and removal proceedings. This is when CAIR-CA stepped in to represent him. It took three years before his case was heard in court. Ultimately, he and his family were granted asylum, a decision initially contested by the Department of Homeland Security, but eventually conceded.





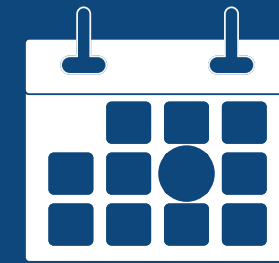
ADVANCING OUR ENGAGEMENT

LEGISLATIVE WORK & IMPACT

THREE LEGISLATIVE WINS



Those who are incarcerated now have the right to religious clothing, headwear, and grooming with the enactment of SB 309.



K-12 students now have a full day of excused absence time per semester for religious reasons with AB 1503.



State employees now have allotted time off to celebrate religious and cultural holidays, such as Eid, Diwali, and Vaisakhi, with SB 461.

ANOTHER SUCCESSFUL CAPITOL IFTAR

CAIR-CA, along with Speaker of the Assembly, Assembly member Anthony Rendon (D-Lakewood), hosted the 17th Annual Capitol Ramadan Iftar in Sacramento on April 10, 2023.

Approximately 150 California lawmakers, leaders, and advocates within the Muslim community attended the event, including Muslim lawmaker Bill Essayli (R-Riverside), who made history in the November 2022 elections as the first American Muslim to be elected to the California Assembly.

A SUCCESSFUL MUSLIM DAY AT THE CAPITOL

CAIR-CA celebrated its 12th Annual Muslim Day at the Capitol with over 400 participants attending meetings with nearly 100 elected officials, including Attorney General Bonta and Governor Newsom. Attendees engaged in meaningful dialogue with the officials on issues affecting our communities, building support for key legislative priorities.

These priorities included three CAIR-CA-sponsored bills, SB 309, SB 461, and AB 1503, which passed the State Assembly and were signed into law by Governor Newsom, marking a significant victory for our community.

RECOGNITION OF AMERICAN MUSLIM APPRECIATION AND AWARENESS MONTH

CAIR-CA and partners successfully lobbied to have the State Assembly in Sacramento, plus several cities throughout California, formally recognize August as American Muslim Appreciation and Awareness Month.

These cities—spanning from the Greater Los Angeles Area (including Corona, Orange County, Fullerton, Irvine, and Yorba Linda), to San Diego County (covering San Diego, Vista, and San Marcos), to the Sacramento Valley and Central California region (Sacramento, Folsom, Tracy, and State Center Community College District), as well as the Bay Area (including Albany, Dublin, Fremont, Milpitas, Pleasanton, and Santa Clara)—issued proclamations acknowledging American Muslims' invaluable achievements and contributions to these communities. Additionally, Anaheim declared July to be Muslim-American Heritage Month, further celebrating the rich diversity and heritage of the Muslim community.

PALESTINE WILL BE FREE

PALESTINE ACTION & ADVOCACY

TAKING PROACTIVE MEASURES FOR PALESTINIAN-RIGHTS ACTIVISTS

In today's digital age, where advocacy and activism have increasingly shifted to online platforms, Palestinian-rights activists faced heightened risks of doxxing after October 7. This malicious practice, which involves the unauthorized disclosure of personal information online, took on particularly alarming forms against activists, who found their pictures displayed on doxxing trucks and websites such as Canary Mission, where they were unjustly labeled as antisemites and subjected to campaigns urging employers not to hire them.

Recognizing the urgency of these threats, CAIR-CA responded by organizing a webinar focused on anti-doxxing strategies and social media safety tailored to the unique challenges these activists face.

The webinar, attended by more than 1,500 people, was led by security experts from Equality Labs, who provided detailed guidance on how attendees could protect their digital presence on platforms such as Instagram, Facebook, and LinkedIn. The instruction offered comprehensive strategies for enhancing online security, emphasizing account and device security, how to minimize potential damage, and ways to stay safe without deleting social media accounts.

BASIM ELKARRA SPEAKS UP FOR PALESTINE IN A MEDIA TOUR

CAIR-SV/CC Executive Director Basim Elkarra has dedicated himself to speaking out about the hardships faced by Palestinians. He has conducted over 50 media interviews on CNN, ABC, FOX, CBS, NBC, and others.

In an interview with NPR, Basim shared his thoughts on the immense suffering and devastation experienced by Palestinians in Gaza, “This is the worst catastrophe for Palestinians since the Nakba in 1948.”

He emphasized the loss of innocent lives, noting “the death toll of nearly 8,000 children.” He stressed the urgent need for humanitarian aid and called for a ceasefire to end the violence. Additionally, Basim stressed the importance of speaking out against the injustices faced by Palestinians, and highlighted, “...this is the first genocide that’s televised on social media.”

Basim also underscored the need for accountability, stating, “Our elected officials... have the moral obligation to speak out because this is being done in our name; this is being done with our bombs and our taxpayer dollars.” He urged for solidarity and support to address the humanitarian crisis and work toward justice, peace, and reconciliation.



KAOUD FAMILY MEMBERS RETURN HOME AFTER BEING STRANDED IN GAZA

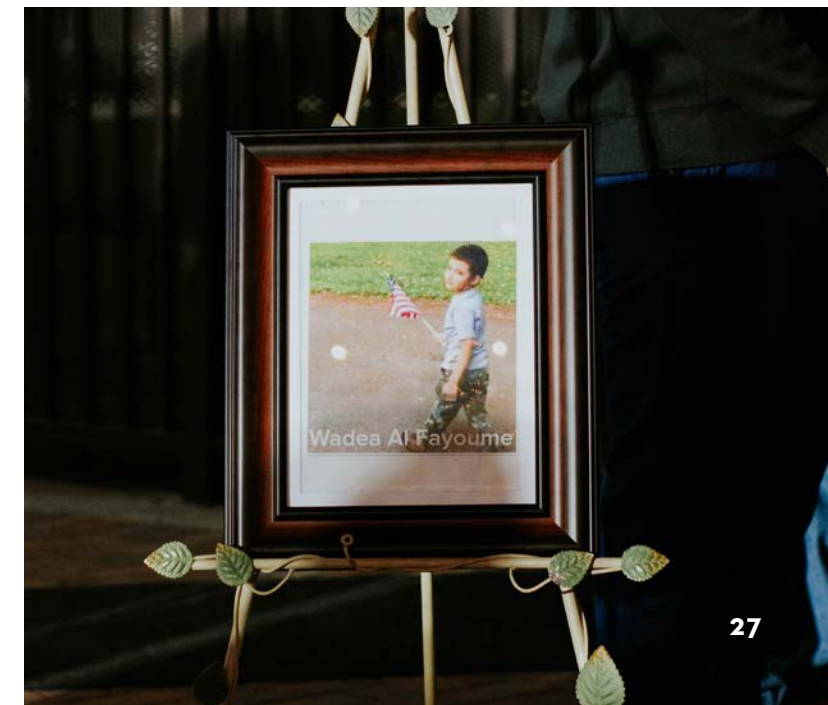
Despite being American citizens, six brothers in the Kaoud family faced extreme hardship in their attempts to leave Gaza. The U.S. State Department’s assistance fell short, leaving them trapped in the middle of Israel’s violent and ongoing assault on Gaza.

On October 26, CAIR-CA held a press conference where Jamal Kaoud’s daughters Shamiss and Dooneya and Esam Kaoud’s daughter Helal shared their families’ struggle to get their fathers back home and voiced their deep frustration and anger after the State Department failed to help or give them answers. After weeks of uncertainty and tireless advocacy—including a lawsuit filed by Project ANAR on behalf of three of the Kaoud men—all six of the men were able to leave Gaza safely. CAIR-CA’s advocacy efforts were instrumental in helping the Kaoud brothers return home.

VIGIL FOR WADEA AL-FAYOUME AND ALL VICTIMS OF ISLAMOPHOBIA AND WAR

CAIR-CA, along with the Islamic Society of Orange County, Project Islamic H.O.P.E, and the Islamic Shura Council of Southern California, held a vigil for Wadea Al-Fayoume, the six-year-old Palestinian-American boy killed in a hate-fueled attack, and all victims of Islamophobia and the war in Gaza.

“It is a trust upon us to protect every child. No child deserves to feel insecure or threatened. Every child is precious. Every child deserves protection. Whether they are Muslim, Christian, Jewish, Palestinian, Israeli, American, White, or Black—every child deserves that protection,” said CAIR-LA Executive Director Hussam Ayloush.





NORTHERN CALIFORNIA CITIES LEAD WITH CEASEFIRE RESOLUTIONS

On October 24, 2023, Richmond became the first city in the nation to adopt a “Ceasefire Now” resolution in response to the war in Gaza. This historic action set a precedent, inspiring Oakland, San Francisco, and other cities around the state and country to pass similar resolutions. The adoption of the resolutions marked a pivotal moment in local and national politics, demonstrating the power of grassroots mobilization in addressing international crises.

“While some may question the value of local governments weighing in on international conflicts, resolutions like these communicate very strongly that ‘We see you. We care about this also.’ It is also an important way for communities and local legislators to articulate that U.S. funding should be focused in the U.S. We don’t have money for schools or homes but are sending billions of dollars to Israel.”

CAIR-CA was instrumental in guiding and supporting the adoption of the Oakland and San Francisco resolutions. Through informational sessions and ongoing advocacy, it provided valuable resources and knowledge to both community and council members. This collaborative approach was key in framing resolutions that were informed, balanced, and focused on the urgent need for a ceasefire and peaceful resolution in Gaza.

These three resolutions sparked a movement in California. In fact, after the Richmond, Oakland and San Francisco resolutions were adopted, several other cities including Yurok Tribe, Folsom, Davis, Hollister, Long Beach, and Cudahy adopted similar resolutions in 2023.

PROTECTION FOR A PALESTINIAN STUDENT FROM UNFAIR REPERCUSSIONS

CAIR-CA assisted Jana Abulaban, who was graduating from El Camino College (ECC). She was a model student and served as the Associated Students Organization President and on two hiring committees. Because of her commitment to her school community, academics, and activism, she was selected by ECC’s Commencement Committee to speak during her school’s graduation ceremony. During her speech, she dedicated her graduation to all “Palestinians who have lost their lives and those who continue to lose their lives every day due to the oppressive apartheid state of Israel killing and torturing Palestinians as we speak.” Jana was wrongly attacked on social media and various national publications.

Instead of defending her from these attacks, ECC issued a public statement that gave into the false and hateful campaign against Jana. CAIR-CA advocated on her behalf to inform the school of the harm its actions caused and to ensure that there were no retaliatory actions taken against her. She was able to finish her post-graduation tasks and presentation.

CAIR-CA EXECUTIVE DIRECTORS SPEAK UP FOR PALESTINE IN THE MEDIA



NBC - The Rise of Islamophobia on School Campuses

CAIR-SFBA Executive Director Zahra Billoo spoke with NBC about the rise in Islamophobia across grade school and college campuses. She emphasized the degree and extreme nature of anti-Palestinian and anti-protestor activities that were resulting in the unfair targeting of students. Most notably, she corrected the newscaster as he attempted to push an Israel narrative of the events on October 7. She reiterates the use of the word “occupation,” and clearly communicated that there was a leadup of what the world saw on October 7.

NBC - The Rise of Anti-Muslim Bigotry, Hate Incidents

In the shadow of rampant reports of antisemitism, CAIR-CA CEO Hussam Ayloush discussed the under-reporting of anti-Muslim bias, bigotry, and harassment across America. He drew attention to the 65% of students surveyed in CAIR-CA’s 2023 School Bullying Report who have experienced Islamophobia on their campuses. He noted that these incidents are often unreported. He also clarified the meaning of “From the River to the Sea” and “Free Palestine” as statements of freedom and the end of apartheid.

Spectrum News - The Humanitarian Crisis in Palestine

CAIR-CA CEO Hussam Ayloush discussed the humanitarian crisis in Palestine. He discussed America’s role in the crisis, the unfair collective punishment of civilians by Israel, the harm to Palestinian civilians before October 7, and the misuse of our tax dollars by Israel. He clearly denied the validity of Israel’s false claims of beheaded babies and reiterated that the fault of the crisis lies with Israel’s occupation of Palestine.



CAIR-CA LAUNCHES THE 'GAZA MEDIA GROUP'

CAIR-CA spearheaded an initiative, with the support of Palestinians in the Bay Area, to establish the Gaza Media Group. This collective aims to provide local media with authentic firsthand accounts from individuals directly impacted by the war.

The group consists of Palestinian Americans who share a deeply personal connection to Gaza, with many members having suffered tragic losses of family. For some, this was as many as 100 extended family members, highlighting the profound personal toll of the conflict.

CAIR-CA's involvement in organizing this group underscores its commitment to ensuring that the voices and narratives of the Palestinian people are heard. "Our goal is to amplify the stories often missing from mainstream media," said CAIR-SFBA Executive Director Zahra Billoo. "These are the voices of people whose lives have been upended by the war in Gaza."

MUSLIM YOUTH LEADERSHIP PROGRAM STUDENTS GO TO THE CAPITOL

CAIR-CA hosted 45 high school students during its 17th annual Muslim Youth Leadership Program (MYLP) at the State Capitol in Sacramento.

MYLP is our flagship, four-day, intensive retreat in Sacramento designed to introduce American Muslim high school students to the areas of media, law, and government—avenues that shape public opinion and public policy.

Students from across the state participated in workshops on community organizing, leadership development, and social justice—and took part in a mock legislative session on the State Capitol Assembly floor.

We are so proud of the newest MYLP graduates and cannot wait to see their continued growth in the future.

ENGAGING THE YOUTH: MUSLIM GAME CHANGERS NETWORK

CAIR-CA held the Muslim Game Changers Network (MGN) program, now in its 10th year. MGN is a 10-week innovative program designed to empower young Muslims by equipping them with the skills and knowledge to become effective leaders and advocates in their communities, with a focus on civic engagement, social justice, and community organizing. Throughout the program, students engaged in workshops, interactive sessions, and hands-on projects to prepare them to be effective changemakers while providing them the opportunity to create deep connections with like-minded Muslim students. CAIR-CA graduated over 108 MGN students in 2023—that’s 108 students empowered to drive change in their communities across California.

One student shared, “My experience at MGN was fantastic. I had the chance to meet new people and had some great interactions that I still look back on. Also, I was able to connect to others from the Muslim community and learn more about the kinds of things we Muslims go through. Being a Muslim student in America, this experience has shown me how to take care of myself and how to deal with certain things that I may come across, such as being bullied or harassed in any way, shape, or form.”



LEARNING OUR OWN IMMIGRANT STORIES

CAIR-CA organized an Intergenerational Storytelling Workshop at the Mingei International Museum. This event provided a platform for immigrant families to share their stories and allowed first-generation youth to discuss their experiences of living in the U.S. By hosting the workshop at the museum, the event emphasized the importance of cultural interconnectivity. This and other efforts reinforce the Muslim identity of our future leaders.



ADDRESSING ANTI-BLACK BIAS IN THE MUSLIM COMMUNITY

For Black History Month, CAIR-CA held discussions on Black history and discrimination on multiple high school campuses, addressing the various biases existing within Muslim communities. The students were alarmed to learn about their own bias and the racism that exists against the Black community. The students also explored institutional racism and the disadvantages that the Black community often faces.

LIFE LESSONS THROUGH SOCCER

CAIR-CA had the privilege of working with an exceptional group of youth through a partnership with Masjid Annur, Al-Misbaah, and other community organizations. Together, they organized a soccer tournament that highlighted the skills and commitment of these youth, as well as those from the surrounding area. Despite suffering a narrow defeat, a few months later the team secured the league title. This turnaround underscored the invaluable lessons that can emerge from setbacks. Predominantly comprised of Afghan refugees, this group exemplified unwavering passion and resilience—an embodiment of overcoming challenges and achieving success.



CONNECTING WITH THE COMMUNITY

OUTREACH

CAIR-CA FACILITATES ESTABLISHMENT OF OFFICE OF IMMIGRANT AND REFUGEE AFFAIRS

CAIR-CA, along with 22 other immigrant and refugee-serving organizations, welcomed the unanimous vote to establish an Office of Immigrant and Refugee Affairs (OIRA) by the Orange County Board of Supervisors. The motion addresses the withdrawal of the United States military from Afghanistan and the need to support Afghan arrivals in Orange County. OIRA helps these and other immigrant and refugee communities within the county obtain legal and county services in coordination with local nonprofits.





CAIR-CA FURTHER STRENGTHENS ITS TIES TO THE COMMUNITY VIA MASAJID OUTREACH

Throughout 2023, CAIR-CA staff visited over 60 Bay Area masjid (mosques) during Friday prayers—more than triple last year’s number—from as far north as Santa Rosa and as far south as Monterey (170 mile radius). Some mosques received up to eight visits and many up to five. Community Engagement Coordinator Sami Rehman, who holds degrees in Islamic Law and Theology and Classical Islamic Text, was invited by mosque leaders to give the Friday khutba (sermon) at 24 of the visited mosques throughout the year.

The outreach program is more than just a series of visits—it’s an opportunity to connect, listen, and respond to the needs and concerns of the Muslim community in the Bay Area. Each visit provides an opportunity for CAIR-CA to engage in meaningful dialogue and to educate the community about its civil rights, immigration, and advocacy programs.

CAIR-CA EDUCATES MORE THAN 500 NEWLY ARRIVED AFGHANS

The CAIR-CA Afghan Refugee School Impact (ARSI) project educated 500 newly arrived Afghans about their rights and responsibilities, as well as the opportunities available to them through our Afghan Family & Youth Engagement Programs. CAIR-CA hosted numerous sessions to listen and learn about the concerns and needs of these individuals and provided many presentations to help them successfully begin their lives in the United States. As a result, some of the Afghans we served opened new businesses in San Diego and enrolled in community colleges. Additionally, CAIR-CA helped several newly arrived Afghans become advocates for their community by encouraging them to attend and play an active role in CAIR-CA’s Muslim Day at the Capitol in 2023, where they effectively advocated for their fellow Afghans and other Muslims across the United States.

ARSI/Afghan Youth Mentoring Program

CAIR-CA partnered with the University of California San Diego and California Department of Social Services to sub-contract over \$3,000,000 to organizations across the state that serve school-age Afghan children who moved to California after July 2021. Several dozen partner organizations, including Islamic Circle of North America, Support Lives, Maristan, and many others, came together to serve hundreds of families that benefited from the grant.

CAIR-CA RESPONDS TO THE NEEDS OF REFUGEES WITH GRANTS AND CRITICAL SUPPORT

Throughout the past year, CAIR-CA provided crucial support to Afghan refugees resettling in the Sacramento Valley and Central California area, a region that welcomed the largest number of refugees in the latest wave of immigration. By engaging with the Afghan community early in the resettlement process, CAIR-CA gained vital insights into their immediate needs and leveraged this information to successfully advocate for the community with local elected officials, securing grants and support from the County and City of Sacramento, Tracy, Folsom, and Rancho Cordova. This support not only focused on the needs of the Muslim community but also fostered meaningful relationships with elected officials across the region.
